Section 8 — Governance

Current (2024)

- 8. Governance
- 8.1. The affairs of the Association shall be managed by the Board and is hereafter referred to as "the Board".
- 8.2. Meetings of the Board and Membership shall follow the Roberts Rules of Order.
- 8.3. The Annual General Meeting is the forum by which the Board will be elected.
- 8.4. The following Officers shall be elected at the Annual General Meeting and be voting members of the Board for 2-year terms:
- President Elected in odd number of years
- Vice President Elected in even number of years
- Secretary /Registrar Elected in odd number of years
- Treasurer Elected in even number of years
- Female Director Elected in odd number of years
- House League Director Elected in even number of years
- All Star Director Elected in odd number of years
- Coaching Director Elected in even number of years
- Umpire Director Elected in odd number of years
- Junior / Senior Director Elected in odd number of years
- 8.5. Each member of the Board shall be elected by a majority vote or acclamation.
- 8.6. The Coordinators for various divisions may be appointed by the Board, and may include non-voting positions (T-Ball/Rally Cap, U9, U11, U13, U15, U18, IT Coordinator).
- 8.7. The immediate Past President of the Association shall, automatically on retiring as President, be appointed as a member of the Board, in an ex-officio position, with no voting privileges.
- 8.8. In the event of non-interest or vacancies by public indifference, the Board may appoint persons to various Board positions, until the next annual general meeting. 8.9. To qualify for the Board, an individual must be a member of the association as set out in section 5 and be eighteen (18) years of age.
- 8.10. Nominations for all Board positions must be given at the AGM by a member, and seconded by a member. The nominee must accept the nomination either in person at the AGM or in writing.

- 8.4. Elected Officers (2-year terms):
- President Elected in odd-numbered years. In order to be President of CBS Kiwanis Minor Baseball Association, you must have served on the Board for a minimum of 2 years. [REVISED 2025- Todd Powell]
- Vice President Elected in even-numbered years
- Secretary / Registrar Elected in odd-numbered years
- Treasurer Elected in even-numbered years
- Female Director Elected in odd-numbered years
- House League Director Elected in even-numbered years
- All Star Director Elected in odd-numbered years
- Coaching Director Elected in even-numbered years
- Umpire Director Elected in odd-numbered years
- Junior / Senior Director Elected in odd-numbered years
- 8.4.1. Additional Officer positions may be created, or existing positions amended, by approval of the membership at an Annual General Meeting. [ADDED 2025 Maggie Corcoran]
- 8.4.2. The Board may, by majority vote, adjust or expand the responsibilities of Officer roles during the year to address operational needs. Any such changes shall be reported to the membership and included for confirmation at the next Annual General Meeting. [ADDED 2025 Maggie Corcoran]
- 8.8. The Board shall solicit interest from members and appoint interim board members until the end of the position term, or until challenged at the following AGM. [REVISED 2025- Maggie Corcoran]
- 8.11. Family Representation Only one member per family or relative may serve on the Board. [ADDED 2025 Todd Powell]
- 8.12. Removal of a Board Member Should a Board Member consistently fail to perform duties or fail to act in the best interest of the Association, they may be removed by a two-thirds majority vote of the Executive members present at an Executive Meeting considering such a motion. [ADDED 2025 Maggie Corcoran]
- 8.13. Conflict of Interest Board Members shall comply with conflict-of-interest provisions, and any committee members shall disclose the conflict/potential conflict in accordance with the Association's Conflict of Interest Policy. [ADDED 2025 Maggie Corcoran]

- 4.5. If a coaching position receives applications from multiple eligible members, one of which includes a current Board member, the selection process shall proceed as follows: [ADDED 2025 Billy Taggart]
- a. The Association shall refer the matter to an independent third party. This third party will be presented with the applications submitted by interested coaches.
- b. The independent third party shall make a recommendation based on criteria listed in 4.3(e).
- c. The decision made by the independent third party shall be final.
- d. The independent third party must have no affiliation with the Association or any of the applicants to ensure impartiality. House League
